2024 COUNTY LEGISLATIVE REPORT



Through its involvement in the Association of County Commissions of Alabama, the County Commission works in unison with all Alabama counties during the Regular Session of the State Legislature to strengthen our ability to enhance county government efficiencies and services to residents.

In just the first week of April, the County Commission's legislative advocacy efforts, through continued communication and collaboration with state legislators and fellow commissioners across Alabama, have resulted in the following legislative achievements for the county, our residents and the state as a whole:

- State lawmakers move companion bills to improve mental health access & care at local level**
Committees in the Senate and House of Representatives approved Senate Bill 240 by Sen. Will Barfoot and House Bill 359 by Rep. Russell Bedsole, respectively, on April 3. If either bill makes its way this session through the complete legislative process, much improvement will be made in local access to inpatient mental health care and in the day-to-day local processes used to connect individuals in crisis to necessary treatment. The legislative initiative, perhaps most notably, will acknowledge that substance abuse can often accompany a mental health condition, allowing local governments to partner with the State in utilizing opioid settlement dollars to fund treatment for those suffering from co-existing mental health and addiction issues.
- House approves bill to strengthen processes for Alabama tax sales & tax lien auctions**
The House of Representatives passed House Bill 270 by Rep. Chris Sells on April 2 and sent the bill to the Senate for its consideration. If approved by the majority of members in the Senate and by the Governor in the same form, the bill will update Alabama's tax sale and tax lien auction processes to ensure compliance with recent U.S. Supreme Court requirements and provide homeowners with more options to negotiate their property tax debts and, in turn, better protect their home equity.
- House approves bill to allow local collaboration in delivery of 911 services**
The House of Representatives passed House Bill 307 by Rep. Ed Oliver on April 4 and sent the bill to the Senate for its consideration. If approved by the majority of members in the Senate and by the Governor in the same form, the bill will set up a process for interested 911 centers in Alabama to contractually — and voluntarily — partner with one another on operational services and, subsequently, strengthen the effectiveness and efficiency of 911 services for local citizens.
