### Sheriff Jody Wade Warns Bibb **County Residents of Phone Scam**

Bibb County Sheriff Jody Wade has issued an important alert regarding a phone scam targeting local residents. Reports have surfaced of individuals impersonating law enforcement, specifically using the name "Deputy Steven Scafford," in an attempt to deceive community members.

According to Sheriff

Wade, these scammers are calling residents and requesting a callback, often leaving a phone number to appear legitimate. However, the Bibb County Sheriff's Office has confirmed that these calls are fraudulent.

office, officials advise verifying directly by calling 205-926-4683.

### **Judge Wiggins Inducted** Into The Hall of Fame

The Alabama Lawyers Association's Hall of Fame honors lawyers who have been licensed to practice law for twenty-five years or more, and who have made significant contributions to the cause of justice. On Thursday, March 6, 2025, the Association paused to honor Judge Marvin W. Wiggins. A man whose courage, intellectual accomplishments, professional achievements, and community contributions deserved the highest recognition.

Judge Wiggins has dedicated his life to justice, leadership, and community service. On January 17, 1999, he made history as the first African American Circuit Judge in Alabama's Fourth Judicial Circuit, which serves Bibb, Dallas, Hale, Perry, and Wilcox counties. In February 2001, he was appointed Presiding Judge of the circuit, a role he continues to hold, now serving his third term with a commitment to fairness and judicial excellence.

A distinguished legal professional, Judge Wiggins holds a Master of Laws (LL.M.) from

Emory University, a Juris Doctor from Howard University School of Law, and a Bachelor of Science from Alabama State University. See Judge Wiggins on page 2


improving the legal system. Judge Wiggins has been a driving force behind numerous community initiatives. He chairs the Clearinghouse Blackbelt Faith-Based and Non-Profit Initiative Programs, which unite churches and nonprofits to provide after-school programs, youth mentorship, and drug-free camps. As Program Chairman of the Hale County Community Enrichment Society, Inc., he works to empower local communities and enhance opportunities for children. Additionally, he serves as Board Chairman for the Fourth Judicial Circuit Community Corrections Program, Inc., a nonprofit focused on alternative sentencing for non-violent offenders and life-skills development. His other community efforts include Summer Youth Employment Programs, Basketball Leagues, Tutorial Programs, and enrichment trips for underprivileged

His affiliations extend to politics, sports, and faithbased organizations. He is a member of the Alabama Democratic Conference and New South Coalition. Project Charlie, which started in 2022, raises funds to get thermal imagers (TI) into fire departments across the state of Alabama. TIs help firefighters detect trapped victims through thick smoke and debris.

In July of 2022, Alder Springs Volunteer Fire Department in Marshall County, Alabama, was called out to a structure fire where a grandfather and two children were trapped inside. The grandfather and one child were located and rescued. The other child was

brought out by the Albertville Fire Department, but she took longer to locate and had severe smoke inhalation. This was a young girl named Charlie. Medics from Marshall County Health System Ambulance Service provided patient care until they reached the hospital where she passed







100 YEARS

3 Men Held In Garnsey Killing - Mine Worker Shot Through Forehead

Arrested early Saturday morning when police halted an automobile in which they were riding on a highway several miles west of Birmingham, three men are being held without bond in the city Jail as suspects in a murder at Garnsey, Bibb County, Alabama, Friday night. The men are G. Bartlant, Naod Oragin and A. Galetti, all residing in the vicinity of Garnsey. They were in arrested at the instance of Bibb County authorities, who believe them responsible for the murder of Warlick Siddon, reported to have been shot to death in a row over a dog. Siddon was shot in the forehead, the bullet piercing his brain. Officers McFarland and Virgil Sandefer made the arrest. Bibb county authorities were- expected to reach Birmingham Saturday night. Although complete details of the tragedy had not been obtained by police Saturday afternoon, it is understood from reports that Galetti is accused of having fired the shot which killed Siddon. He is held on a charge of murder, while his companions are held on investigation charges. All of the men Involved are understood to have been mine workers.



#### **25 YEARS**

Two Survive Plane Crash In North Bibb On April 13

Excitement was in the voice of the dispatcher as she issued the call that a plane had reportedly gone down in the vicinity of Big Springs Road in Woodstock last

Thursday.

Emergency personnel sped to the scene to find a single-engine airplane nose down in a swampy area on the edge of a large field.

Two men, pilot Ronald Diggs, and passenger J. Bon Hartline, were in the plane at the time of the crash. According to North Bibb Police Chief Michael Bates,

"The plane came from Illinois, home of the two men, and had been to Florida, they were apparently on their way back home when they experienced engine trouble and tried to land in the field."

Investigators were called in and were trying to determine the cause of the crash. Bates said the two men were conscious when pulled from the wreckage and had cuts and apparent broken bones.


They were dispatched to Druid City Hospital in Tuscaloosa where their injuries were deemed, "non-life threatening."

Randy Hutchins, who lives less than 100 yards from the crash site, saw most



of the action. "They were heading towards Greenpond and sounded like they were trying to start their engine. When they saw they couldn't make it they tried to turn around to land in the field they just passed over. About 30 yards from the field, they hit the top of a tree and it threw them down into the swampy area. I' had the family call 911 and I ran down to see if they were alright. They were lucky."

Bates said the plane had traveled to Lakeland, Fla. when it crashed.

### **CENTREVILLE WATER/SEWER DEPT.**

Meeting Date: March 10, 2025

Mayor Oakley called the meeting to order at 4:30. All members of the board

were present. Guests present were: Diane Epperson, Brad Colburn (City employees Rebecca Abercrombie, Leslie Hubbard), and Lynn Hamric with the Press.

1)Water Board Supt. (Larry O.) led an extensive discussion on the work involved and estimated expense on various methods of correcting the hydrant leak (Market/Cedar Streets). There will be an interruption of water to uptown with the length of time depending on which method of corrective action is taken. An estimated cost of \$25,000 was stated. The Board instructed Larry to obtain more pricing information/cost differences, etc. Mayor Oakley is to check with the insurance provider regarding a shutting off of water to businesses, etc.

2)Mayor Oakley also stated that Christian Sanford out of Katie Britts office is covering Bibb County. He has spoken with her about the possibility of getting infrastructure funding since Centreville has never requested assistance. He is to put together a proposal to forward to our DC elected officials rquesting to be put on the appropriations list.

3) Larry brought to the attention of the board the need for "policy enforcement" or a "resolution" whichever will bring to code the number of houses (families) on a single meter. It appears there is a policy in place that needs enforcing.

4)Surplus/Scrap Equipment

There are several trucks and pcs of equipment that need to either be put on a surplus list (and up for bid) or sold for scrap. Larry is to provide, by the next meeting, a complete list (inventory) of all vehicles and equipment. Mayor Oakley stated there is a list for insurance purposes. Larry stated that even though some of the they remain under insurance coverage. Per Larry the spray truck us water department property and the sprayer is city property. The sprayer can easily be put on a city truck. Mayor Oakley stated a transfer of equipment would take care of this.

5. Barry Cooner asked if every employee

needed a truck and if every employee

needed to drive the truck home every day. Larry stated that yes, they all needed trucks and that taking them home accomplished two things: 1) employees are on call-out. 2) this is one of the employee benefits. A lengthy discussion about this resulted in Mayor Oakley stating that the city would be liable of an employee was called out to work and were in an accident in their personal vehicle. This matter was questioned and Mayor Oakley is to verify this with City Attorney Mitch Kemmer. Barry stated this is something the board will need to discuss. He had rather see the employees be compensated more and keep the trucks at the water de-

partment building. There are two streets (Market/Walnut and Walnut/Pine Avenue) that must be repaired prior to street paving. These areas are a result of the water department making line re-

pairs. The cost incurred will be the responsibility of the water department.

7. Water Bills failing to reach customers. Rebecca stated that she came into this in the middle of the situation (two weeks ago). She stated 1940 statements were printed and taken to the post office. She said they will go through all accounts and make sure statements are correct. Individuals are encouraged to call/come to city hall and secure a copy of their bill and make payment. There will be no late fees added. If a two-month statement is necessary payment arrangements may be made to pay over two-months and if unpaid at that time it would result in turn off. The city does not turn off water without working with customers to resolve the problem. Linda Lawrence stated that no one is blaming Rebecca for this problem. She also stated that comments need to be stopped on the FaceBook page. The city FB page should be made for announcements only. There was a Policy established in 2023 to this effect. Mayor Oakley stated there was a power outage partway through the printing process and Josh Lambert was able to get the system back up and running. Evidently when the system came back on some statements were double printed. Rebecca stated that every statement will be verified before being mailed. This may result in some overtime.

8. The issue of not being able to pay bills online continues to be a problem. The system has been in place for over a year and has never worked. Mayor Oakley said he and Megan have talked with Chase Bank trying to get this corrected. This has been documented and he hopes to talk with Chase Bank on Tuesday. Rebecca sated she was told it would be late April or early May before it would be operational. The city attorney is ley said he will give them two weeks to correct the problem. Mayor Oakley invited Barry Cooner to come to his office Tuesday and sit in on the phone call.

9. There needs to be a written policy on meter cut-off. There is a wordof-mouth time frame but nothing in writing. Larry stated he has been with the city 15 years and there has never been anything in writing. He requested the board establish a written policy.

10. Water adjustments when leaks occur. The same word-of-mouth policy exists for this. Larry requested a step-by-step policy on how to handle this so that everyone would be treated equally. Larry stated the current metering system can generate a printout hour by hour of water going through the meters. Linda Lawrence then said apparently the \$80,000 computer system is not the problem. Rebecca stated she has not had any problems with the system.

11. Barry Cooner led a discussion concerning the phones at city hall and the lack of citizens being able to talk with anyone. He asked since there is only one number how calls are handled. It was decided that Rebecca would contact AT&T and have the system changed so that when a call comes in it will roll over to as many phones as are operational so more than one person can take calls. Barry stated that the board is just trying to help by bringing citizens concerns to the employees.

Water Department Audit – Don Wallace has not completed the audit. He has requested a one-on-one with employees.

13. Barry brought up the matter of office hours for city hall. City Hall is currently closed on Wednesday afternoons. Employees should work eight to five (40 hour work week) so citizens can pay their water bills. Linda Lawrence agrees with this. A motion was made (Cooner) seconded (Lawrence) that beginning April 1, 2025 employees will work a forty hour work week with an hour for lunch. Motion carried.

Callier ID is not showing up as Centreville, AL but as Cordova. Rebecca is to get with AT&T and

get this corrected. 15. Computer access by non-city employees. becca stated that as of today all non-city employees are blocked on all computers. Barry stated that his concern is that it has taken two weeks for this to happen. A discussion as to whether this was Mayor Oakley's job to oversee ensued. Mayor Oakley stated that you hire employees you trust to do the right thing. That it really is not the responsibility of the Mayor.

16. Transparency. Barry stated that all the board is requesting is complete transparency. Do not hire someone and the board know nothing about it. must be teamwork if business is to be run correctly. It should not be a five to one and he (Barry) would want full support of the board and he feels certain Mike does. Barry said, "don't say I'm trying to micro-manage" because that is not the case. Mayor Oakley said he understood perfectly. Barry stated that he will continue his appointment (board position). Linda agreed with If we had known ahead of time we might could have helped with the problem. When people ask and we don't know what's happening we all look foolish. The board should be the first to know not hear what's going on at city hall on the street. Mayor Oakley said he will make every effort to be transparent and he thinks he has been pretty transpar-

### Matthew Patton's Big Day **Propels West Blocton Varsity Tigers Past Verbena**




